### How this form works

As it can take up to six months to get a charity registered, and Gift Aid increases the value of all donations by a quarter, we have set up a limited company to receive any donations (as loans) until the charity is registered. In this way, the funds needed to bid for the locomotive on 21st June are available. Once the charity is registered, the funds received will be transferred to the new bank account as donations.

When the Trust is granted charitable status, a new bank account will be opened, through which all transactions relating to this donation will take place.
